TERMINATION AGREEMENT

(Lease to Shell)

THIS AGREEMENT, dated _____, 19 _____, between Haynes N. Oberg and Janet S. Oberg, his wife of P. O. Box 402 in Eugene, Oregon (herein called "Lessor", whether one or more), and SHELL OIL COMPANY, a Delaware corporation, with offices at 1219 Westlake Avenue North in Seattle, Washington (herein called "Shell");

WITNESSETH:

In consideration of One Dollar (\$1.00) and other valuable consideration, receipt whereof is hereby acknowledged, Lessor and Shell hereby: (1) Agree that the lease dated March 2, 1959, as amended, supplemented or extended, which (or a memorandum of which) is recorded in Book 312 of Deed Records, Page 99, in the Office of Klamath County Recorder, and by which Lessor leased to Shell (or to Shell's predecessor) certain premises situated at on U. S. Highway 97, in near Chiloquin, County of Klamath, State of Oregon, and fully described in the lease, shall be and is hereby terminated, effective as of January 27, 1964; and (2) Release each other from all claims which either now has against the other under or by virtue of the lease, as amended, supplemented or extended, reserving, however, to Shell its rights thereunder to remove its property from the premises.
