SHERIFF'S DEED

THIS INDENTURE, made this 22nd day of July, 1965,
between J. M. BRITTON, as Sheriff of Klamath County, Oregon,
party of the first part, and KLAMATH COUNTY, a body politic
and corporate of the State of Oregon, party of the second
part;

WITNESSETH:

That, Whereas, pursuant to a judgment obtained by
the party of the second part dated July 15, 1964, in the
Circuit Court of the State of Oregon, for Klamath County, in
a suit entitled County of Klamath, State of Oregon, a public
corporation, Plaintiff, vs. D. & Eldora Konopasek, et al.,
Defendants, No. F 393, said suit being for the purpose of
foreclosing delinquent taxes due for the year 1959-60, and
years subsequent thereto; and,

Whereas, the Judge of said Court entered an Order
in said suit directing that the County Clerk of Klamath County,
Oregon, enter an order for the sale of the real properties
described therein and against which judgment was rendered; and,

Whereas, I caused to be published in the Herald and
News, a daily newspaper printed and published in Klamath County,
Oregon, being a newspaper of general circulation in said county,
in two weekly issues thereof, a notice that said period of
redemption on the real properties described in said suit and
hereinafter described would expire on the 15th day of July,
1965, that redemption may be made of said properties on or
before said date, and that a deed therefor would be given to
Klamath County, Oregon, on July 22, 1965; and,

Whereas, said notice contained the date of the judg-
ment and Decree, the date of the expiration of the period of
redemption, and warning to the effect that all the properties

1 ordered sold under said judgment and decree, unless sooner
 2 redeemed, would be deeded to the County on July 16, 1965, and
 3 that every right or interest of any person in such properties would
 4 would be forfeited forever to Klamath County; and proof of said
 5 publication is hereto attached and made a part hereof; and,

6 Whereas, the lands hereinafter described have not been
 7 redeemed from the judgment aforesaid, and that the same were
 8 contained in said suit above mentioned;

9 NOW, THEREFORE, KNOW YE THAT I, J. M. BRITTON, Sheriff
 10 of Klamath County, Oregon, in consideration of the premises,
 11 and by virtue of the statutes in such cases made and provided,
 12 do hereby grant, bargain, sell and convey unto Klamath County,
 13 Oregon, its successors and assigns forever, the real property
 14 hereinafter described as fully and completely as the party of
 15 the first part can by virtue of the premises convey the same;

16 That all of said real property hereinafter described is
 17 situated in Klamath County, Oregon, and that the figure follow-
 18 ing each separate description is the amount of taxes and
 19 interest due against each of said parcels of real property on
 20 the date hereof, as follows:
