KNOW ALL MEN BY THESE PRESENTS, That SCHOOL DISTRICT NO. 1 OF KLAMATH COUNTY, OREGON, a public school district of the State of Oregon, herein called Grantor, in consideration of the sum of One Dollar (\$1.00) to it paid by KLAMATH COUNTY, a political subdivision of the State of Oregon, herein called Grantee, does hereby grant, bargain, sell and convey unto the said Grantee, its successors and assigns, all of the following real property with the tene-ments, hereditaments and appurtenances situated in the County of Klamath, State of Oregon, bounded and described as follows, to-wit:

Part of Block 1 of Klamath Lake Addition, being more particularly described as follows:

All of Lot 4, East 10 feet of Lot 5, the Northerly 60 feet of the West 40 feet of Lot 5, the Northerly 60 feet of Lot 6, and the Northerly 60 feet of the East 25 feet of Lot 7, all in Block 1, Klamath Lake Addition, Klamath County, Oregon.

TO HAVE AND TO HOLD The above-described and granted premises unto the Grantee, its successors and assigns forever, for a public street, PROVIDED, HOWEVER, That if the premises shall not be used for a public street, it shall revert and revest in the Grantor.
