

1 KNOW ALL MEN BY THESE PRESENTS, That E. H. Heiken, in consideration of Ten
 2 Dollars and other valuable considerations to him in hand paid by M. E. Robinson,
 3 has sold, transferred and assigned, and by these presents does sell, transfer,
 4 assign and set over unto said M. E. Robinson all of his interest in and to the
 5 Trust Agreement dated September 16, 1941, which was recorded December 7, 1942,
 6 in Volume 151 at page 465 of Klamath County Deed Records, and in a further
 7 trust agreement dated October 22, 1941, and in a further trust agreement dated
 8 September 26, 1944, which is amendatory to the two trust agreements first
 9 described, description of the lands included in said trust agreements being as
 10 follows, to-wit:

11 The West half of Northwest quarter; all that part of Southwest quarter
 12 lying West of the recorded right of way of the California Northeastern
 13 Railway's railroad; all that part of Lot Six lying West of the said right
 14 of way; all that part of Lot Seven lying West of said right of way, all
 15 in Section 1, Twp. 40 South, Range 8 E.W.M.; the East half of East half;
 16 Lot Five; Lot Six; Lot Seven; Lot Eight; Lot Nine; all in Sec. 2, Twp.
 17 40 South, Range 8 E.W.M.; the East half of Northeast quarter; the Southwest
 18 quarter of Northeast quarter; the Southwest quarter; the West half of
 19 Southeast quarter; all that part of East half of Southeast quarter lying
 20 West of said right of way; Lot Two; Lot Three; Lot Four; Lot Five, all in
 21 Section 11, Twp. 40 South, Range 8 E.W.M.; all that part of the Northwest
 22 quarter lying West of said right of way in Section 12, Twp. 40 South, Range
 23 8 E.W.M.; the northwest quarter, and all that part of East half lying West
 24 of said right of way, all in Sec. 14, Twp. 40 South, Range 8 E.W.M.; Lots
 25 Six and Seven in Sec. 10, Twp. 40 South, Range 8 E.W.M., in Klamath County,
 26 Oregon; and

27 The Southwest quarter of Sec. 14, Twp. 40 South, Range 8 E.W.M.; the North
 28 half of Southeast quarter of Sec. 15, Twp. 40 South, Range 8 E.W.M.; Lots
 29 10, 11, 12, 13, 14 and 15 in Sec. 15, Twp. 40 South, Range 8 E.W.M., in
 30 Klamath County, Oregon, consisting of 389 acres, more or less.

31 TO HAVE AND TO HOLD the same unto said grantee, his heirs and assigns, forever.
