## SPECIAL POWER OF ATTORNEY.

KNOW ALL MEN BY THESE PRESENTS, That I, HELEN M. WHITMAN, have made, constituted and appointed, and by these presents do hereby make, constitute and appoint ROBERT R. WALKER my true and lawful attorney for me and in my name, place and stead, and for my use and benefit to manage and operate that certain business known as MALIN DRUG STORE, formerly a co-partnership consisting of George Whitman and me and in which I am the surviving partner.

I hereby empower my said attorney to do all acts necessary to manage and operate said business, including but not limited to the following: to demand, sue for, recover, collect and receive all sums of money, debts, rents, dues, accounts, interest, dividends, annuities and demands whatsoever flowing from said business, as are now or shall hereafter become due, owing, payable or belonging to me as said surviving partner; to have, use and take all lawful ways and means, in my name or otherwise, for the recovery thereof, and to compromise, settle and adjust, and to execute and deliver acquittances or other sufficient discharges for any of the same; to bargain, contract for, purchase, receive all stocks and inventories of said business; to bargain for, buy, sell, mortgage, hypothecate and in any and every way and manner deal in and with the goods, wares and merchandise, choses in action and other property in possession or in action, and to make, do and transact all and every kind of business of whatsoever nature or kind dealing with the operation of said business; for me and in my name and as my act and deed, to sign, seal, execute, acknowledge and deliver all agreements, mortgages, pledges, hypothecations, bills of lading, bills, bonds, notes, evidences of debt, receipts, releases and satisfactions of mortgages, judgments and other debts payable to me and other instruments in writing of whatever kind and nature which my said attorney, in his discretion, shall deem to be for my best interests; to sell, discount, endorse, deliver and/or deposit all checks, drafts, notes and negotiable instruments payable to my order or to the order of said

business; to withdraw any moneys deposited in my name and in the name of said business with any bank, and generally to do any business with any bank or banker on my behalf in connection with the operation of said business; also to obtain a purchaser for said business and to sell said business and to execute any and all instruments or documents necessary to the completion of said sale.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming<sup>all</sup> that my said attorney, or my said attorney's substitute or substitutes, shall lawfully do or cause to be done by virtue of these presents.

In construing this instrument and where the context so requires, the singular includes the plural.

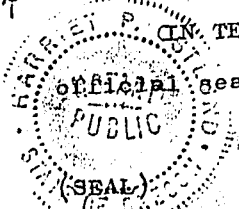
