WHEREAS, a petition praying for the widening of Bisbee Street from Hilyard Avenue to the south line of Lot 15, Block 5 from forty (40) feet in width to fifty (50) feet in width was received by the Board of Commissioners on March 9, 1965, and

WHEREAS, the petition was signed by thirteen (13) property owners who represented over sixty (60) per cent of the property owners who own over sixty (60) per cent of the property frontage, and

WHEREAS, a public hearing was held concerning this matter on April 14, 1965 and notices of the hearing were posted in the vicinity of the street and copies of the petition and notice of public hearing were mailed to the owners affected, and

WHEREAS, the Board of Commissioners did on the 21st day of April, 1965 appoint a Board of Road Viewers to review the road and assess the damages caused by the petitioned widening, and

WHEREAS, the Board of Road Viewers did view the road and made a written report to the Board of Commissioners on the 6th day of May, 1965 and this report was read on two (2) successive terms of the Commissioners on June 9, 1965 and July 14, 1965 and those property owners affected being given notice of the Road Viewers Report, and

WHEREAS, a petition for damages was received on July 6, 1965 from Robert and Helen Caldwell in the amount of \$200.00, and

WHEREAS, this petition for damages was considered by the Board of Commissioners on July 14, 1965 and it was felt to be in the best interests of Klamath County and the motoring public

NOW THEREFORE IT IS HEREBY ORDERED that the Board of Road Viewers Report be accepted by the Board of Commissioners and that Bisbee Street from Hilyard Avenue to the south line of Lot 15, Block 5 in Altamont Acres Subdivision be increased in right-of-way width from forty (40) feet to fifty (50) feet by the acquisition of five (5) feet on either side of the existing right-of-way.
