That portion of Government Lot 11 lying Westerly of the West bank of the Williamson River, excepting therefrom that portion of Lot 11 described as follows: Beginning at a point which is 1083 feet West and 1391 feet South of the Northeast section corner of Section 4, Twp. 35 South, Range 7 East of the Willamette Meridian, Oregon; thence South 105.53 feet; thence East 164.34 feet; thence Northeasterly along the bank of Williamson River to a point due East of the point of beginning; thence West 200 feet to the point of beginning.

That portion of Government Lot 12 lying East of the Easterly right of way line of United States Highway #97.
