Warranty Deed

This Indenture Witnesseth, That ESTON E. BALSIGER and BILLIE L.

BALSIGER, husband and wife,

herein called grantors, in consideration of TEN AND NO/100 (\$10.00) -----
 Dollars to them paid, have bargained and sold and by these presents do grant,
 bargain, sell and convey to

E. M. HENDERSON and HELEN C. HENDERSON, husband and wife,

herein called grantees, their heirs and assigns forever, the following-described
 premises, situated in Klamath County, State of Oregon:

A portion of Block 41 of HILLSIDE ADDITION to the City of Klamath Falls, Oregon, more particularly described as follows, to-wit: Beginning at the Northwesterly corner of said Block 41 of HILLSIDE ADDITION; thence S. 21°14' E., along the Westerly line of said Block 41, a distance of 160.0 feet; thence N. 68°46' E., parallel with Manzanita Street, a distance of 50.0 feet; thence N. 21°14' W., at right angles to Manzanita Street, a distance of 10.0 feet; thence N. 68°46' E., parallel with Manzanita Street, a distance of 17.0 feet; thence N. 21°14' W., at right angles to Manzanita Street, a distance of 150.0 feet to the Southeasterly line of Manzanita Street; thence S. 68°46' W., along said Southeasterly line of Manzanita Street, a distance of 67.0 feet to the point of beginning. SUBJECT TO: (1) 1965-66 taxes which are now a lien but not yet payable. (2) Reservations and restrictions contained in the dedication of Hillside Addition. (3) Reservations and restrictions contained in deed from F. Hill Hunter and Harriet I. Hunter, husband and wife, to A. O. Roenicke, dated May 7, 1935, recorded May 8, 1935, in Volume 104 of Deeds, Page 518, records of Klamath County, Oregon, as follows: "Also giving and granting unto grantee herein the right to use sewer across Lots 5 and 6 of Block 49 Hot Springs Addition to the City of Klamath Falls, Oregon, reserving unto the grantors the right and privilege of changing the location of said sewer without any expense to grantee herein." (4) Reservation and restrictions contained in deed from The Klamath Development Company to F. Hill Hunter, dated November 7, 1928, recorded November 21, 1928, in Volume 83 of Deeds, Page 43, records of Klamath County, Oregon, as follows: "It is understood and agreed that no dwelling house shall be erected on said premises to cost less than \$4,000.00 unless plans for same are approved by party of first part."
