## THE MORTGAGOR

Dollars, bearing even date, principal, and interest being payable in monthly installments of \$ .... 261, 33 on or before the 15th day of each calendar month December 15 . commencing... and to secure the payment of such additional money, if any, as may be loaned hereafter by the mortgage to the mortgage others having an interest in the above described property as may be evidenced by a note or notes. If the mortgage indebtedness is evidenced by more than one note, the mortgage may credit payments received by it upon any of said notes, or part of any payment on one note and part on another, as the mortgage may elect. The mortgagor covenants that he will keep the buildings now or hereafter effected on said mortgaged property or gainst loss by fire or other hazards, in such companies as the mortgage may direct, in an amount not less than the far ith loss payable first to the mortgage to the full amount of said indebtedness and then to the mortgager; all policies ortgages. The mortgagor hereby assigns to the mortgage all right in all policies of insurance carried upon said propers or damage to the property insured, the mortgagor hereby appoints the mortgage as his agent to settle and adjust and apply the proceeds, or so much thereof as may be necessary, in payment of said indebtedness. In the event of the mortgagor in all policies then in lorce shall pass to the mortgage thereby giving said mortgages the right to assignificates. The mortgagor further covenants that the building or buildings now on or hereafter erected upon said premises shall be to air, not altered, extended, removed or demolished without the written consent of the mortgage, and to complete all building construction or hereafter constructed thereon within six months from the date hereof or the date construction is hereafter mortgagor agrees to pay, when due, all taxes, assessments, and charges of every kind levied or assessed against said premis mortgagor or the note and-or the indebedness which it secures or any transactions in connection thorowith or any other lien adjudged to be prior to the lien of this mortgage or which becomes a prior lend by operation of law; and to pay premiums on an expectage building to the property which may be assigned as further security to mortgagee; that for the purpose of providing regularly for the prompt taxes, assessments and governmental charges levied or assessed against the mortgagee on the date installments on principal payable an amount equal to 1/12 of said yearly charges. In case of default in the payment of any installment of said debt, or of a broach of any of the covenants herein or contained in the cation for loan executed by the mortgagor, then the entire debt hereby secured shall, at the mortgagoe's option, become immediately without notice, and this mortgago may be foreclosed. The mortgager shall pay the mortgages a reasonable sum as atterneys fees in any suit which the mortgages defends or prosecutes to ect the lien hereof or to foreclose this mortgage; and shall pay the costs and distuirsements allowed by law and shall pay the cost to the lien hereof or to foreclose this mortgage; and shall be secured hereby and may be included in the decree of foreclosure.
