EXTENSION OF MORTGAGE

TO COVER ADDITIONAL DEBT

THIS AGREEMENT, made and entered into this 25 day of August, 1965, by and between ROBERT L. ASHER and SHIRLEY W. ASHER, husband and wife, hereinafter designated as the Mortgagors and RACHEL IRWIN, a widow, hereinafter designated as the Mortgagee, WITNESSETH:

WHEREAS, the Mortgagors heretofore executed a mortgage acknowledged the day of April, 1964, to the Mortgagee to secure the payment of a promissory note dated February 14, 1964, in the amount of Three thousand and no/100 (\$3,000.00) Dollars which mortgage is recorded in Volume 223, Page 201, Mortgage Records of Klamath County, Oregon, and

WHEREAS, there remains unpaid on said note and mortgage a balance of Two thousand four hundred ten and 04/100 (\$2,410.04)

Dollars plus interest at six (6%) per cent per annum from August 1,

WHEREAS, the Mortgagors desire to borrow an additional sum of Two thousand five hundred and no/100 (\$2,500.00) Dollars from the Mortgagee and

WHEREAS, the Mortgagee is willing to advance said sum upon a note provided the original mortgage heretofore mentioned stands as security for the payment of the same,

NOW, THEREFORE, it is mutually agreed by and between the parties as follows:

I.

That in consideration of the lending of the further sum of Two thousand five hundred and no/100 (\$2,500.00) Dollars to the above mentioned Mortgagors by the Mortgagee which further sum and balance

due under the original mortgage are evidenced by a new promissory note, a copy of said note being substantially as follows:

25 , 1965 August \$4,910.04 Rachel Irwin Each of the undersigned promises to pay to the order of at Ashland, Oregon Four thousand nine hundred ten and 04/100 (\$4,910.04)percent per annum from Aug. 1, 1965 until paid, payable with interest thereon at the rate of Six in any one payment; interest shall be paid installments of not less than \$ 50.00 and \* included in the minimum payments above required; the first payment to be made in monthly monthly , 19 65, and a like payment on the on the LBU day of SEPLEMBER , 19 00, and a like payment on the LBU day of each month thereafter, until the whole sum, principal and interest has been paid; if any of said installments is not so paid, the whole sum of both principal and interest to become immediately due and collectible at the option of the holder of this note. If this note is placed in the hands of any attorney for collection, each of the undersigned promises and agrees to pay the reasonable collection costs of the holder hereof; and if suit or action is filed promises to pay (1) holder's reasonable attorney's fees to be fixed by the trial court and (2) if any appeal is taken from any decision of the trial court, such further sum as may be fixed by the appellate court, as the holder's reasonable attorney's fees in the appellate court. holder's reasonable attorney's fees in the appellate court. /s/ Robert L.
