A parcel of land lying in Tract 9 of ALTAMONT RANCH TRACTS, situated in Section 10, Township 39 South, Range 9 East, W.M., Klamath County, Oregon; the said parcel being described as follows:

Beginning at the intersection of the Easterly line of Washburn Way with the Southerly line of La Verne Avenue; thence Easterly along said Southerly line, 70 feet; thence Southwesterly in a straight line to the Easterly line of Washburn Way, at a point 40 feet Southerly (when measured along said Easterly line) of the point of beginning; thence Northerly along said Easterly line 40 feet to the point of beginning.

The parcel of land to which this description applies contains 1,400 square feet.

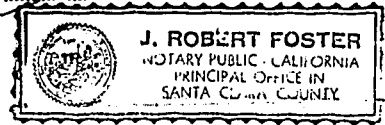

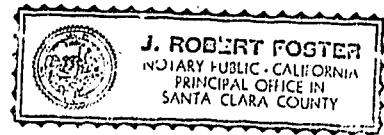
