## EASEMENT DEED

THIS DEED, dated this 25Th day of County, 1965, by and between Klamath County, hereinafter called the "Grantor", and the UNITED STATES OF AMERICA, hereinafter called the "Grantee".

WITNESSETH, that the Grantor, for and in consideration of \$1.00, the receipt of which is hereby acknowledged, does hereby grant and convey unto the Grantee and its assigns an exclusive easement for a Log Scaling Station and appurtenances to be reconstructed, improved, used, operated and maintained, and known as the Bly Log Scaling Station, over, upon, along and across the following described premises situated in the County of Klamath, State of Oregon to-wit:

A tract of land described as follows:

Beginning at the point of intersection of the north right-of-way boundary of Oregon State Highway No. 66 and the west right-of-way boundary of a County road between Section 1 and Section 2, Township 37 South, Range 14 East, W.M., said point bearing N 0° 13' W., 2573.6 feet from the southeasterly corner of said Section 2; thence along the said north boundary line of Oregon State Highway No. 66, bearing N 66°45' W. a distance of 379.55 feet; thence N 0° 27' E. a distance of 90 feet; thence S 89° 33' E. a distance of 360 feet; thence S 0° 27' W. a distance of approximately 240 feet to the point of beginning and containing approximately 1.1 acres.

The acquiring agency is the Forest Service, Department of Agriculture.

Provided, however, that if for a period of five years the Grantee shall cease to use the Log Scaling Station, for the purposes granted, or shall abandon the same, then, in any such events, the premises described shall be freed from said easement as fully and completely as if this deed had not been made. In the event of such non-use for the period stated, the Regional Forester shall furnish to the Grantor a statement in recordable form evidencing such non-use.
