of Sprague River, Oregon, does hereby grant, bargain, sell and convey unto the said HIRAM R. ROBBINS,

and unto his heirs and assigns, all its right, title and interest in and to the following described parcel of real estate, situated in the County of Klamath, State of Oregon, to-wit:

An undivided 900/14,400 interest in Lots Twenty (20), Twenty-one (21), Twenty-eight (28), and Twenty-nine (29), Section 8, Township 35 South, Range 7 E.W.M. according to the official records of Klamath County, Oregon.

TO HAVE AND TO HOLD the same, together with all and singular the hereditaments and appurtenances thereunto belonging or in any wise appertaining to the said HIRAM R. ROBBINS, his heirs and assigns forever.

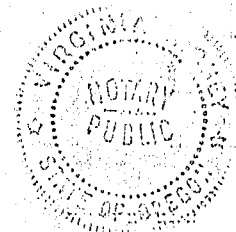
