TEMPORARY RIGHT-OF-WAY DEED

KNOW ALL MEN BY THESE PRESENTS, that Gilchrist Timber Company hereinafter called the "Grantor", for and in consideration of \$1.00, receipt of which is hereby acknowledged, does hereby grant to the United States of America, acting by and through the Forest Service, U.S.D.A., and assigns, a temporary easement to use and maintain the logging road #249 across that portion of the following described real property owned by the Grantor situated in the County of Klamath, State of Oregon, to-wit:

The existing roadway beginning at a point on the south boundary of Lot 3, Section 31, T.25 S., R.9 E. W.M., thence northeasterly over and across the aforementioned Section 31 to a point on the north boundary of the SE $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Section 31, at which point the roadway leaves the property of the Grantor. The said roadway being located as shown on Exhibit A which is attached hereto.

The rights, privileges and authorities herein granted are for the purpose of removing national forest products from the proposed Marmot Butte timber sale area estimated to be approximately 2MM board feet. This grant shall continue as long as needed, for the purpose of removing the above designated timber, and said grant shall expire upon the termination of the resultant timber sale agreement.

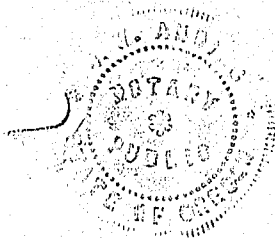

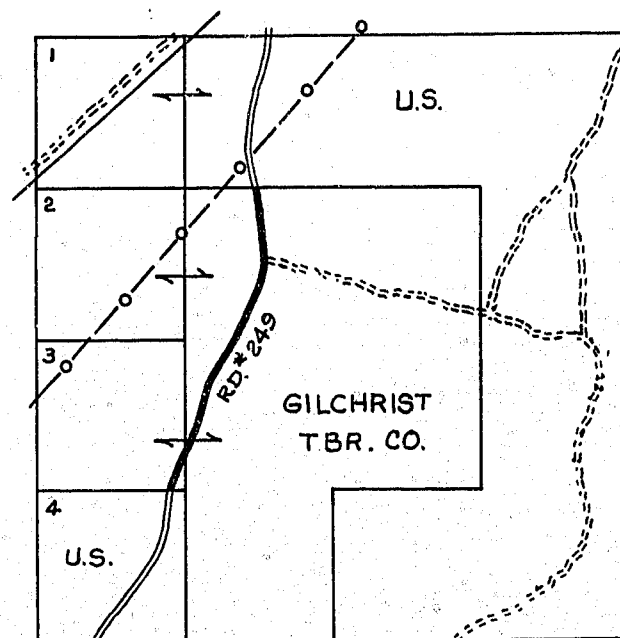
