ROAD USE AGREEMENT

WINSTON H. PATTERSON and LOUISE PATTERSON, husband and wife, residing at 608 Roseway Drive, Klamath Falls, Oregon, and CLYDE R. PATTERSON and IRENE H. PATTERSON, husband and wife, hereinafter called "Grantors", for Ten Dollars (\$10.00) and other valuable consideration, receipt whereof is hereby acknowledged, grant and convey unto WEYERHAEUSER COMPANY, a Washington corporation, Box C, Tacoma, Washington 98401, and its successors and assigns, hereinafter called "Weyerhaeuser", a perpetual and nonexclusive right and easement to use the following described real property in Klamath County, Oregon, to-wit:

The existing roads traversing the land subdivisions set forth as on the attached "Exhibit A", and located approximately as indicated on said Exhibit A, together with relocations of any portion, or portions, thereof as hereinafter provided for,


for all road purposes.

SUBJECT TO:

- A. The following encumbrances:
- 1. Acreage and use limitations under provisions of the United States Statutes and regulations issued thereunder.

All contracts, water rights, proceedings, taxes and assessments relating to irrigation, drainage, and/or reclamation of said lands; and all rights of way for roads, ditches, canals and conduits, if any of the above there may be.

- 2. Waiver of riparian rights from F. H. Downing, et ux, to the United States, dated July 5, 1905, recorded September 16, 1905, in Deed Volume 18 at Page 375, Records of Klamath County, Oregon.
- 3. Waiver of riparian rights from T. J. Downing to the United States dated July 27, 1905, recorded April 28, 1906, in Deed Volume 20 at Page 74, Records of Klamath County, Oregon.
- 4. As to portion in S_2^1 of NE_4^1 of Section 5, Township 41 South, Range 8 East: Subject to rights of way of California Northeastern



Railway Company 100 feet wide as granted by deeds recorded in Deed Volume 22 at Page 549, and in Deed Volume 25 at Page 154, Records 2232 of Klamath County, Oregon.

- 5. As to portion in SE¹ of NE¹ of Section 5, Township 41 South, Range 8 East: Rights, if any, pursuant to Easement from Theo. P. Schafer, et al, to The Pacific Telephone and Telegraph Company, dated July 26, 1937, recorded December 15, 1937, in Deed Volume 113 at Page 369, Records of Klamath County, Oregon.
- 6. As to portion in SW_{4}^{1} of NE_{4}^{1} and S_{2}^{1} of NW_{4}^{1} of Section 4 and SE_{4}^{1} of NE_{4}^{1} of Section 5, Township 41 South, Range 8 East: Rights, if any, pursuant to Easement from Clyde R. Patterson, et ux, to California Oregon Power Company, dated May 18, 1951, recorded June 12, 1951 in Deed Volume 247 at Page 684, Records of Klamath Falls, Oregon.
- 7. Rights granted to Pacific Power and Light Company in Road
 Use Agreement, recorded May 24, 1962 in Deed Volume 337 at Page 569,
 Records of Klamath County, Oregon; AND
- B. The following terms, conditions and provisions:
- 1. Grantors reserve the right to relocate said roads or any portion, or portions, thereof; provided, however, that:
 - (a) Such relocation(s) shall be at Grantors' expense;
 - (b) Grantors shall provide a road base of sufficient width for a single lane of logging truck traffic with intervisible turnouts, together with such culvert drains as Grantors may elect to install;
 - (c) Grantors shall not be required to provide any rock or cinders for any such relocations;
 - (d) Weyerhaeuser may elect to install additional culvert drains without further permission from the Grantors;
 - (e) Weyerhaeuser may, at no expense to Grantors, elect to rock and cinder any such road relocation(s).

- 2. Upon completion of any road relocation(s) as aforesaid,
 Weyerhaeuser and Grantors shall join in the execution of a recordable new or supplemental road use agreement which shall provide for
 like rights in the road(s) as relocated and which shall also effect
 a release from this agreement of those road(s) which shall thenceforth no longer be subject to this agreement.
- 3. Weyerhaeuser shall repair all road damage resulting from the exercise of its rights hereunder as soon as it is reasonably practicable to do so.
- 4. Weyerhaeuser shall indemnify and save harmless Grantors from and against all claims, loss, cost, liability and expense based upon or arising out of the exercise of the rights granted herein, excepting only such claims, loss, cost or expense as may be occasioned by or based upon the negligent acts or omissions of Grantors.
- 5. All rights herein granted and provided for shall be binding upon and inure to the benefit of the Grantors, their heirs, successors and assigns, and to Weyerhaeuser, its successors and assigns.
