TO PROTECT THE SECURITY of this mortgage the mortgagor agrees that:

(1) All buildings now or hereafter erected on said mortgaged property shall be continuously insured against loss by fire or other hazards in an amount not less than the total debt secured by this mortgage. (2) All policies shall be held by the mortgagee, and be in such companies as the mortgagee may approve and have loss payable first to the mortgagee as its interest may appear and then to the mortgagor. (3) The mortgagor hereby assigns to the mortgagee all rights in all policies and appoints the mortgagee as his agent to settle and adjust any loss. (4) In the event of foreclosure all rights of the mortgagor in all policies then in force shall pass to the mortgagee. (5) He will complete all buildings now under construction and any that may hereafter be built on said property within 9 months from the date of the start of construction. (6) The buildings now on or hereafter erected on said premises shall be kept in good repair, not altered, extended, removed or demolished without the written consent of the mortgagee. (7) He will pay when due any lien which may be adjudged to be prior to the lien of this mortgage or which becomes a prior lien by operation of law. (8) He will pay when due all insurance premiums, taxes, assessments and other public charges levied, assessed or charged against the within described property. (9) He will pay to the mortgagee, on the dates installments of principal and interest are payable, an amount estimated by the mortgagee to be equal to 1/12th of the yearly charges above referred to, next to become due. (10) In case of default in the payment of any installment of said debt or a breach of any covenant herein or contained in the application for loan executed by the mortgagor, then the entire debt hereby secured shall, at the mortgagee's option, become immediately due without notice and this mortgage may be foreclosed.
