

## GRANT OF OVERHANG EASEMENT

KNOW ALL MEN BY THESE PRESENTS THAT

LLOYD V. HOWARD and LETHA W. HOWARD, husband and wife

in consideration of One Dollar (\$1.00) and other valuable consideration to them paid, receipt of which is hereby acknowledged, hereby grant, sell and convey unto PACIFIC POWER & LIGHT COMPANY, a Maine corporation, its successors, and assigns an easement right of way and rights as follows:

- (a) To construct or maintain electrical circuits and/or associated property of whatever nature in a position to overhang the lands described herein.
- (b) To enter upon said land with necessary tools and machinery for the purpose of installing, maintaining, or removing said circuits and/or associated property and
- (c) To remove or trim trees and make the clearing on or over said lands to the extent necessary or desirable.
- (d) Provided however that no poles, towers or anchors shall be erected upon the lands described herein.

The lands subject to this right of way and easement are situate in Klamath County, Oregon, and described as follows:

The Southeast Quarter (SE $\frac{1}{4}$ ) of the Southeast Quarter (SE $\frac{1}{4}$ ) of Section 25, Township 39 South, Range 7 East, W. M.  
This overhang easement is for two 12,000 volt primary wires along the south edge of a public road known as the Keno Plant Road and approximately 590' West of the Clover Creek Road.

Nothing herein contained shall be construed as making PACIFIC POWER & LIGHT COMPANY an operator, owner or person in possession as defined by the Forestry Code of the respective States of either Oregon or California, whichever State may be the one wherein the premises, which are the subject matter hereof, are located.


