ORDER

On April 16, 1966, Karl F., Isabell M. and Richard K. Dehlinger submitted an affidavit that they are the legal owners of the NE_4^1 NE_4^1 , NW_4^1 NE_4^1 , SW_4^1 NE_4^1 , SW_4^1 NE_4^1 , SW_4^1 NE_4^1 , SW_4^1 NE_4^1 , SE_4^1 NE_4^1 , Section 35, Township 37 South, Range $11\frac{1}{2}$ East, W.M., in Klamath County, Oregon, and the water right appurtenant to said lands; that they have abandoned any and all interest in and to said water right and request the same to be canceled.

The water right in question is for the right to the use of not to exceed 32.5 acre feet during any irrigation season, and a quantity for domestic and stock purposes outside of the irrigation season diverted at the rate of one-half cubic foot per second for each 1,000 head of stock, of the waters of Buck Creek, tributary of Lost River, for domestic and stock use and for the irrigation of 3 acres in the NE4 NE4, 2 acres in the NW4 NE4, 4 acres in the SW4 NE4 and 4 acres in the SE4 NE4, Section 35, Township 37 South, Range 112 East, W.M., with a date of priority of 1887, evidenced by certificate of water right issued in the name of James G. Wight and recorded at page 2298, Volume 3, State Record of Water Right Certificates.

ORS 540.621 provides that: "Whenever the owner of a perfected and developed water right certifies under eath to the State Engineer that the water right has been abandoned by him and that he desires cancelation thereof, the State Engineer shall enter an order canceling the water right."

NOW, THEREFORE, it is hereby ORDERED that the right to the use of not to exceed 32.5 acre feet during any irrigation season, and a quantity for domestic and stock use outside the irrigation season diverted at the

rate of not to exceed one-half cubic foot per second for each 1,000 head of stock, of the waters of Buck Creek, tributary of Lost River, for domestic and stock use and for the irrigation of 3 acres in the NE¹/₄, NE¹/₄, lacres in the SW¹/₄ NE¹/₄ and hacres in the SE¹/₄ NE¹/₄, Section 35, Township 37 South, Range 11¹/₂ East, W.M., with a date of priority of 1887, evidenced by certificate of water right issued in the name of James G. Wight and recorded at page 2298, Volume 3, State Record of Water Right Certificates, is canceled.
