AN ORDINANCE vacating a portion of Mesa Street in the Terraces Addition to the City of Klamath Falls, Oregon; and declaring an emergency.

WHEREAS, on April 4, 1966, pursuant to Resolution No. <u>1492</u>, the Common Council of the City of Klamath Falls, Oregon, held a public hearing on a proposal to vacate that portion of Mesa Street extending from the northerly boundaries of Lot 1, Block 3, and Lot 1, Block 4, and the southerly boundaries of Lot 4, Block 3, and Lot 5, Block 4, all in The Terraces Addition to the City of Klamath Falls, Oregon; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City that said alley be vacated; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

That portion of Mesa Street extending from the northerly boundaries of Lot 1, Block 3, and Lot 1, Block 4, and the southerly boundaries of Lot 4, Block 3, and Lot 5, Block 4, all in the Terraces Addition to the City of Klamath Falls, Oregon, be, and the same is hereby vacated.

Section 2.

The immediate enactment of this ordinance being deemed necessary for the preservation of the public peace, health and safety, an emergency is declared to exist, and this ordinance shall be in full force and effect from and after its passage and its approval by the Mayor.
