WHEREAS, on April 4, 1966, pursuant to Resolution No. <u>1494</u>, the Common Council of the City of Klamath Falls held a public hearing on a proposal to vacate the alley between the southerly boundary of the United States Bureau of Reclamation "A" Canal right-of-way and the northerly lot lines of Tax Lots 129, 130, 131, 132, 134 and 135, Williams Addition, from the westerly boundary of said Tax Lot 129, southeasterly to Main Street, all in the City of Klamath Falls, Oregon; and

WHEREAS, the Common Council of the City of Klamath Falls has determined that it is to the best interest of the City that said alley be vacated; therefore,

THE CITY OF KLAMATH FALLS ORDAINS AS FOLLOWS:

Section 1.

The alley between the southerly boundary of the United States Bureau of Reclamation "A" Canal right-of-way and the northerly lot lines of Tax Lots 129, 130, 131, 132, 134 and 135, Williams Addition, from the westerly boundary of said Tax Lot 129, southeasterly to Main Street, all in the City of Klamath Falls, Oregon, be, and the same is hereby vacated.

Section 2.

The immediate enactment of this ordinance being deemed necessary for the preservation of the public peace, health and
