

## <u>WARRANTY</u> DEED

HAWKINS and NORA E. HAWKINS, his wife, of Klamath County, State of Oregon, have bargained and sold, and by these presents do hereby grant, bargain, sell and convey unto said RICHARD H. HAWKINS and NORA E. HAWKINS, his wife, their heirs and assigns, all the following bounded and described real property situated in the County of Klamath and State of Oregon:

PARCEL I: That portion of the NE%SW% of Section 32, T. 39 S., R. 12 E.W.M., which lies Northwest of the Langell Valley Irrigation District Drainage Ditch, the parcel hereby described aggregating 3 acres, more or less.

Also the SW4NW4 of Section 32, T. 39 S., R. 12 E.W.M., in Klamath County, Oregon.

Also the NWMANWA of Section 32, T. 39 S., R. 12 E.W.M., in Klamath County, Oregon.

FARCEL II: Beginning at the Northeast section corner of Section 31, T. 39 S., R. 12 E.W.M., thence West 360 feet; thence South 822 feet; thence East 360 feet; thence North 822 feet, more or less, to the point of beginning, con-taining 6.8 acres, more or less.
