ORDER

This matter coming on regularly before the above-entitled Court upon the petition of the Administrator, the Security National Bank of Reno, and the said administrator having filed its final accounting and petitioned for final distribution and proof having been made to the satisfaction of the Court that notice had been given of the said settlement of the account and hearing of the petition in the manner and for the time required by law, the Court finds:

1. That the said account is in all respects true and correct.

2. That due and legal notice to creditors has been given in the manner required by law.

3. That all claims against the estate, except for administrator's and attorney's fees and final costs of publication have been paid and the estate is ready for final distribution and closing.

4. That the remaining amount due for administrator's fees is \$136.87; for attorney's fees is \$250.00 and for costs of publication is \$23.65.

5. That the sole heir-at-law of decedent is his mother, LUCILLE FORTNER MORRIS and is the person entitled to receive same.

IT IS THEREFORE ORDERED ADJUDGED AND DECREED as

2 1. That the fiscal account of administrator re, and
3 the same to be finally settled, allowed and approved.

4 2. That the administrator re, and is hereby is
5 allowed and authorized to receive the sum of \$110.87 as and for
6 his salary, and is, said sum being in addition to the amount
7 of \$75.00 per month said to said person for services in such
8 capacity.

9 3. That the attorney for the said estate re, and he
10 hereon is allowed and authorized to receive the sum of \$250.00,
11 said sum being in addition to the amount of \$500.00 previously
12 paid him and services in such capacity.

13 4. That the sum of \$72.65 be, and is hereby is ordered
14 paid to the Clatsop County Record Office for final publication
15 costs.

16 5. That the residue of said estate and any other
17 property, including any amount which is the same may be
18 recovered from the U.S. Department of Interior or distributed
19 to said person or persons as the sole heir-at-law of the above
20 named person. said residue is described as follows:

21 (1) \$1,499.62 in cash.

22 (2) 1/4th interest in that property located in
23 Klamath County, State of Oregon, known as the
24 Bailey Carhardt allotment #66.

25 (3) 1/6 interest in that certain property known
26 as Lot 5 Block 2 in Tract, Klamath County, Oregon.

27 (4) 1/6 interest in that certain property known
28 as Lots 3 & 4, Block 5 FIRST ADDITION TO
29 CHILKATH, OREGON.

30 (5) an undivided 1/3 interest in the Isaac Moses
31 allotment #579, consisting of Lots 12, 13, 20,

33 Range 12 EMM located in Klamath County, State of

35 (6) an undivided 1/4th interest in the sub-
36 surface rights of James allotment #63 located in
37 Klamath County, Oregon.
