PARTIAL RELEASE OF MORTGAGE

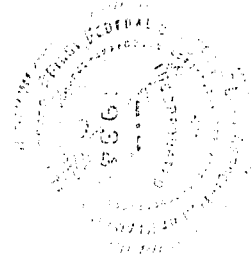
