LAST WILL AND TESTAMENT

I, SOPHIA STONE, being of the age of sixty four (64) years, being resident and domiciled in Josephine County, Oregon, and being of disposing mind and memory, and having in mind the natural objects of my bounty, and not acting under the duress or undue influence of any person whomsoever, and desiring to make a final disposition of my property, do hereby declare and publish this document as my Last Will and Testament.

FIRST. I hereby revoke any and all wills, codicils and testamentary dispositions heretofore made and executed by me.

SECOND. I direct that the expenses of my last illness and of my funeral be paid first, and I direct that my executor shall make the necessary arrangements for my funeral and burial.

THIRD. I direct that my just debts, if any there be at my death, and all claims against my estate, including the expenses of administering my estate shall be paid next.

FOURTH. I hereby empower my executor to lease, encumber, sell, exchange or otherwise dispose of or encumber all or any part of my property, real, personal or mixed, in such manner, at such times, and upon such terms as my executor shall deem to be in the interest of my estate, such sale or other disposition to be made at public or private sale in the discretion of my executor without any reference to the order of disposition, and without necessity for any petition, citation, hearing, order or any other action of any kind or nature.

FIFTH. I hereby declare that my only living children are as follows: Reta Smith, a daughter, presently residing at Tri-City, Oregon; Ethel Marie Andreasen, a daughter, presently residing at North Hollywood, California; and Albert L. Stone, a son, presently residing at Klamath Falls, Oregon.

SIXTH. All the rest, residue and remainder of my estate

whether real, personal or mixed, and wheresoever situated, I give, devise and bequeath unto my husband, Harry M. Stone; but if said Harry M. Stone shall predecease me, or in the event that said Harry M. Stone and I shall both die in a common calamity or disaster so that it is impossible to ascertain which survived the other, I give, devise and bequeath the aforesaid rest, residue and remainder of my estate, whether real, personal or mixed and wheresoever situated unto my aforesaid children, Reta Smith, Ethel Marie Andreasen, and Albert L. Stone, share and share alike.

SEVENTH. Except as herein otherwise expressly provided, I hereby direct that if any legatee or devisee named in this will shall predecease me, the interest of such legatee or devisee shall pass to his or her lineal heirs by right of representation.

EIGHTH. I hereby appoint my husband, Harry M. Stone, as executor of this, my Last Will and Testament, and I direct that said executor serve without bonds; in the event that said Harry M. Stone shall be unable to so serve, or shall not desire to assume such function as executor, then and in either or such events, I hereby appoint my daughter, Reta Smith, as executrix of this, my Last Will and Testament, and I direct that said executrix serve without bonds.
