

## SATISFACTION OF MORTGAGE

Beginning at the Southerly line of the Klamath Falls-Ashland Highway (Greensprings Highway) at a stake which is South 135 feet and South 61°56' West 374 feet from the quarter corner common to Sections 28 and 33, Township 39 S.R. 8 E.W.M.; thence South 61°56' West 374 feet along the Southerly line of said highway to a stake; thence South 1576.9 feet to a stake on the Northerly right of way line of the Weyerhaeuser logging railroad; thence North 54°12' East 406.85 feet along said right of way line to a stake; thence North 1514.3 feet to the place of the beginning, containing 11.70 acres, and being in the E½NW¼ of Section 33 Township 39 S. R. 8 E.W.M., Klamath County, Oregon, being the portion thereof lying Easterly from a line equal distance between the East and West boundary lines of said tract and containing 5.85 acres, more or less.

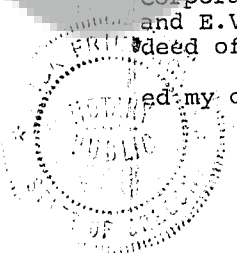
