

GRANT OF RIGHT OF WAY

THIS AGREEMENT, made this 25th day of April, A. D. 1966, by and between

L. L. Little and A. C. Little, husband and wife

part ies of the first part, and PACIFIC POWER & LIGHT COMPANY, a Maine corporation, party of the second part.

WITNESSETH: That the said part ies of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations to them in hand paid, the receipt whereof is hereby acknowledged, do by these presents grant, bargain, sell and convey to said party of the second part, its successors and assigns, a right of way for its pole or tower and wire lines and other facilities for the transmission and distribution of electricity and the transmission of communication and control signals; also the right to install guys and anchors which are necessary or desirable outside of said right of way; also the right to remove the trees, including all trees outside of said right of way, which in the judgment of the grantee could or may fall across or upon said right of way or across or upon any guys anchored outside of said right of way; and to make the clearing necessary or desirable for the purposes aforesaid, across that certain real property, situated in Klamath County, State of Oregon and more particularly described as

That portion of the NE $\frac{1}{4}$ NE $\frac{1}{4}$, Section 17, Township 37S, Range 1SE,
Willamette Meridian lying northerly of State Highway No. 66.

Said right of way to be 10 feet wide, 5 feet on each side of the pole or tower and wire lines as now surveyed through said premises or hereafter constructed, but reserves the right to cultivate said right of way.

Said part ies of the first part grant to the party of the second part the right of ingress and egress to the right of way for the purpose of erection, maintenance, repair, or removal of the second party's electrical and transmission equipment, likewise to include the right to construct and maintain access roads outside of the right of way if deemed necessary upon the part of the party of the second part, however, the location of which must be approved by the parties of the first part.

Nothing herein contained shall be construed as making the party of the second part an operator, owner or person in possession as defined by the Forestry Code of the respective States of either Oregon or California, whichever State may be the one wherein the premises, which are the subject matter hereof, are located.
