

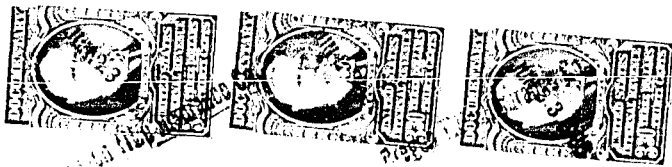
KNOW ALL MEN BY THESE PRESENTS, That Harvey L. Lasley and
