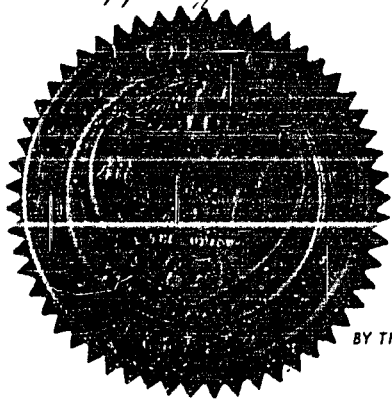


## Notarial Commission
