## WARRANTY DEED

Lot 8, Section 4, Township 35 South, Range 7 East of the Willamette Meridian, less that portion described as:

Beginning at a point where the West bank of the Williamson River intersects the South Boundary line of Lot 8 in Section 4, Township 35 South. Range 7 East, Willamette Meridian, Oregon; thence West 425 feet to West boundary of said Lot 8; thence North 165 feet; thence East 545 feet to West bank of Williamson River; thence South and West following the West bank of said river to place of beginning less that portion described as follows:
