C. MORROW and ELIZA MORROW, husband and wife, Grantees, the following described premises situated in Klamath County, Oregon, to-wit:

Lot 13, of Sportsman Park, Klamath County, Oregon, according to the official plat thereof on file in Klamath County, Oregon.

Subject to: The agreement of January 25, 1924, recorded February 15, 1924, in Vol. 63 at page 460 of Klamath County, Oregon, deed records concerning the operation of the dam and control of the water levels of Upper Klamath Lake; reservations contained in the dedication of Sportsman Park; any easements of record; and co building and use restrictions contained in agreement between grantors and grantees as follows:

- (1) That grantees will not suffer or permit any unlawful, unsightly or offensive use to be made of said premises nor will they suffer or permit anything to be done thereon which may be or become a nuisance or annoyance to the neighborhood.
