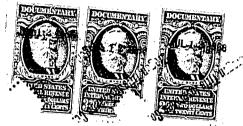

## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That LLOYD D. DANIELS and DELBERTA M. COLLINS, husband and wife, hereinafter called the Grantees, do hereby grant, bargain, sell and convey unto the Grantees, as Tenants by the Entirety, their heirs and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the State of Oregon County of Klamath, described as follows, to-wit:

10 East of the Willamette Meridian, and running thence East
a distance of 115.75 feet to an iron pin; thence North
0 deg. 02' West a distance of 62.5 feet to an iron pin; thence
West 115.75 feet to an iron pin; thence South 0 deg. 02'
East a distance of 62.5 feet, more or less, to the point of
beginning, being a portion of W½S½N½SE¼SW¼ of Section 1,
Township 41 South, Range 10 E.WM.

TRACT "G"

Beginning at an iron pin which lies East along the Section line a distance of 1672.5 feet and North 0 deg. 02' West along the center line of McKinley Street a distance of 825 feet and East a distance of 40 feet from the iron monument which marks the Southwest corner of Section 1, Township 41 South, Range 10 East of the Wilamette Meridian, and running thence East a distance of 115.75 feet to an iron pin; thence North 0 deg. 02' West a distance of 62.5 feet, to an iron pin; thence West a distance of 115.75 feet to an iron pin; thence South 0 deg. 02' East a distance of 62.5 feet, more or less, to the point of beginning, and being a portion of the W½S½N½SE¼SW¼ of Section 1, Township 41 South, Range 10 East of W. M.
