1 KNOW ALL MEN BY THESE PRESENTS, That SWAN LAKE MOULDING COMPANY, an Oregon  
2 Corporation, Grantor, in consideration of Ten Dollars to it paid, has bargained  
3 and sold and by these presents does hereby grant, bargain, sell and convey unto  
4 ERICKSON INVESTMENT COMPANY, a California Corporation, and JAMES F. STILWELL,  
5 Grantees, their successors, heirs and assignees as follows: An undivided 9/10ths  
6 interest therein to said Erickson Investment Company and an undivided 1/10th  
7 interest therein to said James F. Stilwell, the following described premises  
8 situated in Klamath County, Oregon, to-wit:

9 Beginning at the iron pipe marking the Southeast corner of Enterprise  
10 Tract 32 in Section 3, Township 39 South, Range 9 East of the Willa-  
11 mette Meridian, Klamath County, Oregon, and running thence West along  
12 the South line of Tract 32 a distance of 209.57 feet, more or less, to  
13 an iron pipe marking the Easterly line of Austin Street; thence N.34°07½'  
14 E. along the Easterly line of Austin Street Northeasterly at right angles  
15 to the center line of South Sixth Street a distance of 161.08 feet, more  
16 or less, to an iron rod which lies on a line which is parallel to and  
17 120 feet Westerly at right angles from the East line of Tract 32; thence  
18 North along said parallel line and the East line of Austin Street, 891.3  
19 feet, more or less, to an iron rod which is 323 feet South of the North  
20 line of Section 3 and which also marks the boundary between the lands  
21 of the Swan Lake Moulding Company and of William L. Wales, Jr.; thence
