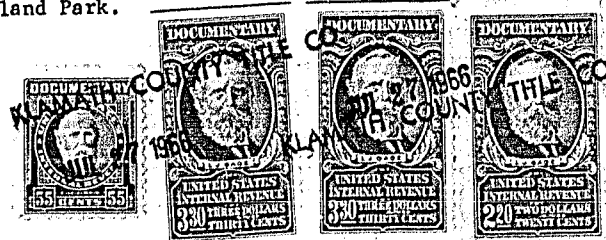
This Indenture Witnesseth, THAT H. L. McMILLIN and KATHERINE E. McMILLIN,
