CERTIFICATE OF WATER RIGHT

This Is to Certify, That THOMAS & VIOLA H. PLEMONS
WALLACE & LAWRENCE E. PLEMONS
of Box 154, Beatty, State of Oregon, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Alice P. Miller Well No. 1

a tributary of Sprague River
supplemental irrigation of 158.1 acres

for the purpose of

under Permit No. G-350 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from September 7, 1956

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
1.98 cubic feet per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the SE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 4, T. 35 S., R. 12 E., W. M.
Well located 1479 feet East and 376 feet North from the S $\frac{1}{4}$ Corner, Section 4.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 3 acre feet per acre for each acre irrigated
during the irrigation season of each year;

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.



19.0 acres Lot 5 (SW $\frac{1}{4}$ NW $\frac{1}{4}$)
Section 10
T. 36 S., R. 12 E., W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of
use herein described.
