does hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Klamath County, State of Oregon to-wit:

The South half of the Southeast quarter of the Southeast quarter southerly of Lost River, Section 34, Township 40 South, Range 10 East, Willamette Meridian, lying northeast of Oregon State Highway #39. Said power line center line to be two feet on private property from Highway #39 right of way line and a total of eighteen feet wide together with the necessary guying as shown on Exhibit A attached hereto and made a part hereof.

Together with the right of ingress and egress over the adjacent lands of the Grantor for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.


