other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

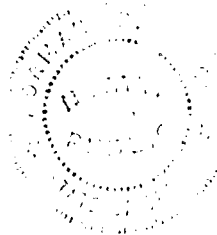
