# CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** LADDIE & CARL RAJNUS

of Route 2, Box 784, Klamath Falls, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Rajnus Wells 1 and 2

a tributary of Tule Lake  
irrigation of 33.8 acres

for the purpose of

under Permit No. G-1296 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 4, 1959

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.42 cubic foot per second, being 0.22 c.f.s. from Well No. 1 and 0.20 c.f.s. from Well No. 2

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the No. 1 SE $\frac{1}{4}$  NW $\frac{1}{4}$ ; No. 2 SW $\frac{1}{4}$  NW $\frac{1}{4}$ ; Section 13, T. 40 S., R. 11 E., W. M. Wells located No. 1 - 130 feet West and 1435 feet South; No. 2 - 1800 feet West and 2540 feet South; both from the NE $\frac{1}{4}$  Corner, Section 13.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3 acre feet per acre for each acre irrigated during the irrigation season of each year;

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:


