acknowledged, has bargained and sold and by these presents does grant, bargain, sell and convey unto

half of the following described real property situate in Klamath County, Oregon, to-wit:

Lots 4, 7, 15, 19 and those portions of Lots 3, 41, 14 and 21 lying West of the Highway, excepting the following:

A tract of land in Section 21, Township 35 S. R. 7 E.W.M., more particularly described as follows: Beginning at the quarter corner common to Sections 16 and 21, said township and range, thence South 27°54' East a distance of 692.3 feet, more or less, to a point on the center line of U.S. Highway No. 97, the aforesaid point being the true point of beginning of this description; thence South 9°27'45" East along the center line of Highway No. 97 a distance of 200.0 feet; thence South 80°32'15" West at right angles to aforesaid Highway centerline a distance of 302.0 feet, more or less, to an existing fence; thence Northerly along the line of aforesaid fence 200.0 feet; thence North 80°32'15" East 303.0 feet, more or less, to the true point of beginning, containing 1.39 acres, more or less,

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining;
