SUBORDINATION AGREEMENT

LOAN NO. 103053

KNOW ALL MEN BY THESE PRESENTS, That, for One Dollar and other good and valuable consideration, receipt of which is hereby acknowledged, and upon the conditions hereinafter set forth, THE FEDERAL LAND BANK OF SPOKANE, a corporation of Spokane, Washington, owner of that certain mortgage dated February 26, 1960, executed by Glenn W. Hunnicutt and Edna M. Hunnicutt, husband and wife,

and recorded as instrument No. 48860 in Book 195 at page 127 of the Mortgage records of Klamath County, State of Oregon, hereby agrees that the lien of said mortgage shall be subordinate to the interest of the Pacific Power & Light Company, a corporation, under that certain right of way easement dated August 10, 1966 executed by Prentiss K. Puckett, a single man, and recorded August 11, 1966 in Book M-66 at page 8166, Deed Records of Klamath County, State of Oregon, as instrument No. 8439. This agreement is dependent upon and subject to the condition that The Federal Land Bank of Spokane hereby expressly reserves all rights against all parties liable for the payment of the debt secured by said mortgage; and the rights of said bank and all persons who may have any interest in or lien upon part or all of the property covered by said mortgage shall not be released or prejudiced by reason of the failure of any person to consent to this subordination.
