KNOW ALL MEN BY THESE PRESENTS, That I, AGNES JONES

have made, constituted and appointed and by these presents do make, constitute and appoint

(15) To employ, pay and discharge clerks, workmen, brokers and others, including counsel and attorneys in connection with the exercise of any of the foregoing powers;
