A G R E E M E N T 10-6-66 H66

THIS AGREEMENT made and entered into this 27th day of November, 1966, by and between DONALD B. MAUSSHARDT and CONSTANCE J. MAUSSHARDT, husband and wife, hereinafter called First Parties, and F. LOYAL RAMEY and LOUELLA RAMEY, husband and wife, hereinafter known as Second Parties;

W I T N E S S E T H:

WHEREAS, First Parties are owners of Lot 27 in Loma Linda Heights Addition to Klamath Falls, Klamath County, Oregon, and Second Parties are owners of Lot 28, Loma Linda Heights Addition to Klamath Falls, Klamath County, Oregon; and

WHEREAS, said lots are adjoining; and

WHEREAS, the lots of said First Parties and Second Parties are subject to a Declaration of Conditions and Restrictions executed by JOHN T. GLUBRECHT, et ux, to the public, dated August 4, 1955, recorded August 5, 1955, in Deed Volume 276 at page 330, Records of Klamath County, Oregon, as amended by JOHN F. GLUBRECHT, et al, on December 1, 1955, recorded on January 5, 1956, in Deed Volume 260 at page 263, Records of Klamath County, Oregon; and

WHEREAS the aforesaid Declaration of Conditions and Restrictions contains a provision requiring all buildings upon lots subject to said Declaration to be set back so that no part thereof extends closer than 20 feet from the front street property line of said lots; and,

WHEREAS, First Parties dwelling upon said lot 27, Loma Linda Heights is located 14.2 feet from the front street property line of the said lot 27;

THEREFORE, Second Parties in consideration of Ten and no/100 Dollars (\$10.00) paid by First Parties to Second Parties, the receipt of which is hereby acknowledged, and other valuable consideration, does hereby consent that the said provision in the aforesaid Declaration of Conditions and Restrictions relating to the 20 foot set-back line

as applied to First Parties and said lot 27, be, and the same hereby is, changed, waived and modified so that the Parties of the First Part, their grantees, heirs and assigns shall have the right to build and maintain a building and residence dwelling 14.2 feet from the street front property line of said lot 27, Loma Linda Heights Addition to the City of Klamath Falls, Klamath County, Oregon.
