2 KNOW ALL MEN BY THESE PRESENTS, That PRENTISS K. PUCKETT, a
3 single man, hereinafter called the grantor, in consideration of
4 Ten & No/100, (\$10.00), and other consideration DOLLARS, to
5 grantor paid by HELEN E. POPE, a widow, and RICHARD A. POPE, a
6 married man, hereinafter referred to as grantee, does hereby
7 grant, bargain, sell and convey unto the said HELEN E. POPE, a
8 widow, and RICHARD A. POPE, a married man, and to the survivor of
9 them, as joint tenants with the right of survivorship, and not as
10 tenants in common, that certain real property, with the tenements,
11 hereditaments and appurtenances thereunto belonging or appertain-
12 ing, situated in the County of Klamath and State of Oregon,
13 described as follows, to-wit:

14 Lot 9 in Block 40 FIRST ADDITION in the City of Klamath
15 Falls, Klamath County, State of Oregon.

16 TO HAVE AND TO HOLD the above described and granted premises
17 unto the said HELEN E. POPE, a widow, and RICHARD A. POPE, a
18 married man, and to the survivor of them, and to the heirs and
19 assigns of the survivor, forever.

20 And said grantor hereby covenants to and with said grantee
21 that grantor is lawfully seized in fee simple of the above granted
22 premises, free from all encumbrances and that grantor will warrant
23 and forever defend the above granted premises and every part and
24 parcel thereof against the lawful claims and demands of all per-
25 sons whomsoever.

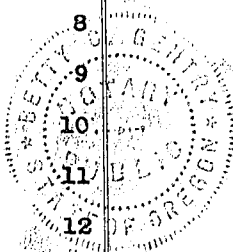
