For value received the undersigned Grantors, James L. Harris and Thelma L. Harris, husband and wife do hereby grant to PACIFIC POWER & LIGHT COMPANY, a corporation, its successors and assigns, the Grantee, an easement or right of way for an electric transmission and distribution line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and the right to place all or any part of such line in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described real property in Klamath County, State of Oregon to-wit:

Beginning at a point South 37' West along the North-South center section line a distance of 400 feet from the center of Section 10, Township 36S, of Range 6E of the Willamette Meridian; thence continuing along said section line a distance of 200 feet; thence North 89°17' East parallel to the East-West center section line a distance of 100 feet to a point; thence North 37' East, parallel to said North-South section line a distance of 200 feet to a point; thence South 89°17' West, parallel to said East-West center section line a distance of 100 feet, more or less, to the point of beginning.

Together with the right of ingress and egress over the adjacent lands of the Grantor S for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing such line and appurtenances, and exercising other rights hereby granted.

All such rights hereunder shall cease if and when such line shall have been abandoned.

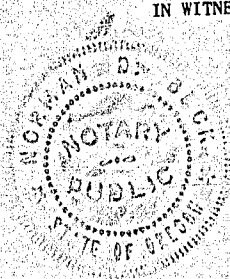
