I, Robert W. Straub, State Treasurer of the State of Oregon, do hereby certify that, pursuant to the Inheritance Tax Law of Oregon, no inheritance tax has been found due from the Estate of Earle W. L. Palmer, deceased, who died on or about the 13th day of April, 1966.

The following described real property (a) located outside the county of probate, or (b) included in an unprobated estate was considered in determining no tax liability:

A parcel of land situate in Klamath Falls, Klamath County, Oregon described as follows, to-wit: Beginning at a point which is North 1,332 feet on section line between sections 19 and 20 from corner common to section 19, 20, 29 and 30 of Township 38 South, Range 9 E.W.M., and 30 feet East on the Sixteenth line between the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ and the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 20, Township 38 South, Range 9 E.W.M.; thence Easterly along said sixteenth line and parallel to section line between sections 20 and 29 a distance of 463 feet to a point; thence Southerly and parallel to section line between sections 19 and 20 a distance of 250 feet to a point; thence Westerly and parallel to section line between Sections 20 and 29 a distance of 463 feet to a point; thence Northerly and parallel to section line between sections 19 and 20 a distance of 250 feet to the place of beginning; all in the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 20, T. 38, S., R. 9 E.W.M., and containing 2.66 acres, more or less. EXCEPTING so much thereof as has heretofore been conveyed to the Oregon State Highway Commission by deeds recorded on August 25th, 1955 in Vol. 277, P. 29, Deed Records of Klamath County, Oregon and recorded September 19th, 1958 in Vol. 304, P. 167, Deed Records of Klamath County, Oregon.
