CERTIFICATE OF WATER RIGHT

This Is To Certify, That MARSHALL W. POOLE, DOROTHEA M. POOLE,
AND ROBERT MOISIO
of Star Route, Chiloquin, State of Oregon, has made proof
to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of
Copperfield Creek and Sprague River for the purpose of
a tributary of Upper Klamath Lake
irrigation of 313.0 acres
under Permit No. 23733 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from September 23, 1955

that the amount of water to which such right is entitled and hereby confirmed, for the purposes
aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed
6.5 cubic foot per second; being 5.9 c.f.s. from Sprague River and 0.6 c.f.s.
from Copperfield Creek

or its equivalent in case of rotation, measured at the point of diversion from the stream.
The point of diversion is located in the Creek: SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 34, River: SW $\frac{1}{4}$ SW $\frac{1}{4}$,
SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 26, T. 34 S., R. 8 E., W. M. Diversion points located: Creek:
6620 feet West and 2470 feet South, River: 2630 feet West and 920 feet North,
2540 feet West and 3430 feet North, all from the $\frac{1}{4}$ Corner between Sections 26 & 35.

The amount of water used for irrigation, together with the amount secured under any other
right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second
per acre, or its equivalent for each acre irrigated and shall be further limited
to a diversion of not to exceed 3 acre feet per acre for each acre irrigated
during the irrigation season of each year;

and shall
conform to such reasonable rotation system as may be ordered by the proper state officer.
A description of the place of use under the right hereby confirmed, and to which such right is
appurtenant, is as follows:
