

do hereby grant, bargain, sell and convey unto the said grantees, their heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Klamath and State of Oregon, bounded and described as follows, to-wit:

Lots 4, 5, 6 and 7, of Block 1 of Canal Addition to the City of Klamath Falls, Oregon. Also the Southerly part of Lot 3 of Block 1 of Canal Addition to the City of Klamath Falls, Oregon, described as follows:

Beginning at the corner of Lots 3, 4 and 5; thence Southeasterly on the line extended between Lots 4 and 5 a distance of 32.93 feet to the alley; thence Southwest along the Northwesterly line of the alley 12.42 feet to the South corner of Lot 3; thence Northwesterly on line between Lots 3 and 5, 16.69 feet; thence North 20.42 feet to the point of beginning.
