9 FOR AND IN CONSIDERATION of the sum of Two Thousand
10 Five Hundred and no/100 Dollars (\$2,500.00) paid to plaintiff by
11 W. M. Raymond, the defendant in the above-entitled action, partial
12 satisfaction in the amount of \$2,500.00 is hereby acknowledged
13 of a certain Judgment rendered in said action on the 13th day of
14 May, 1966, in favor of Standard Oil Company of California, the
15 plaintiff in said action, and against the defendant in said
16 action for the following sums: \$4,358.99, with interest thereon
17 at the rate of 6% per annum from July 1, 1964, until paid; \$2,394.20
18 with interest thereon at the rate of 6% per annum from October 1,
19 1964, until paid; \$2,629.33 with interest thereon at the rate
20 of 6% per annum from July 1, 1963, until paid; \$422.90 with interest
21 thereon at the rate of 6% per annum from November 1, 1963, until
22 paid; and \$957.90 with interest thereon at the rate of 6% per annum
23 from August 1, 1962, until paid; together with plaintiff's costs
24 and disbursements in the sum of \$24.40, which Judgment is docketed
25 in Judgment Lien Docket No. 20, page 289, and the Clerk of said
26 Court is hereby authorized to enter partial satisfaction of record
27 of said Judgment in said action; and

28 Plaintiff Standard Oil Company of California does hereby
29 release from the lien of said Judgment the following described
30 real property situated in the County of Klamath, State of Oregon,

1 That part of Tract 22A of Enterprise Tracts,
2 described as follows:

3 Beginning at a point on the North Right-of-Way
4 line of Shasta Way which lies North 89° 08' East
5 a distance of 2782.3 feet and North 0° 49' West
6 a distance of 15 feet from the iron pin which
7 marks the Southwest corner of Section 34, Town-
8 ship 38 South, Range 9 East of the Willamette
9 Meridian in Klamath County, Oregon, and running
10 thence; North 0° 49' West a distance of 300 feet
11 to a point; thence South 89° 08' West a distance of
12 115 feet to an iron pin; thence North 1° 17' East
13 a distance of 372 feet to an iron pin which lies on
14 the Southerly right-of-way line of the U.S.R.S. "A"
15 Canal; thence Easterly and Southerly following the
16 Southerly right-of-way line of the "A" Canal to its
17 intersection with the North right-of-way line of
18 Shasta Way; thence Westerly along the North right-
19 of-way line of Shasta Way to the point of beginning.
