66-419 All of Enterprise Tract Number 26 except the South 697 (Six Hundred Ninety-seven) feet and except the East 260 (Two Hundred and Sixty) feet thereof, also  
All of Enterprise Tract Number 31 (Thirty-one) except that portion which is platted as SUNNYLAND, as shown by the duly recorded plat thereof




