KNOW ALL MEN BY THESE PRESENTS, That Ralph Parker, a single man,

in consideration of Ten and No/100----- (\$10.00) ----- Dollars,
and other good and valuable consideration
to grantor paid by Alex Kalita and Emilie Kalita, husband and wife,

, hereinafter called the grantee,
does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A tract of land in Lot 16 of Section 7 Township 35 South Range 7 East of the Willamette Meridian, more particularly described as follows:

Beginning at the intersection of the Westerly right of way line of Oregon State Highway No. 427 and the South line of Lot 16, said township and range; thence
Westerly along the said south line of said Lot 16, 150 feet to a point;
thence
North 0°57' West 150 feet to a point; thence
Easterly and parallel with the south line of said Lot 16, 150 feet more or less to the West right of way line of Oregon State Highway No. 427;
thence
South 0°57' East along said westerly right of way line 150 feet, more or less, to the point of beginning.
