ORDER

On March 31, 1967, notice was given by certified mail in accordance with the provisions of ORS 540.631 to 540.650 to Supervisor, Winema National Forest, Post Office Building, Klamath Falls, Oregon, as owner of the lands to which a water right hereinafter described is appurtenant, of the State Engineer's intention to cancel said right.

The water right in question is for the use of not to exceed 0.10 cubic foot per second of the waters of South Fork of Trout Creek, tributary of Sprague River, for domestic and general logging camp use, including locomotives, boilers, etc., to be used in the Southwest one-quarter of Section 25, Township 36 South, Range 9 East, W.M., with a date of priority of January 30, 1930, and is evidenced by certificate of water right issued in the name of Shaw Bertram Lumber Company and recorded at page 8759, Volume 8, State Record of Water Right Certificates.

On May 3, 1967, the State Engineer received a letter from H. B. Rudolph, Forest Supervisor, Winema National Forest, stating that the Forest Service has no objection to the cancelation of the above described water right.

NOW, THEREFORE, it is hereby ORDERED that the right to the use of not to exceed 0.10 cubic foot per second of the waters of South Fork of Trout Creek, tributary of Sprague River, for domestic and general logging camp use, including locomotives, boilers, etc., to be used within the Southwest one-quarter of Section 25, Township 36 South, Range 9 East, W.M., with a date of priority of January 30, 1930, as evidenced by certificate of water right

issued in the name of Shaw Bertram Lumber Company and recorded at page 8759,  
Volume 8, State Record of Water Right Certificates, is canceled.
